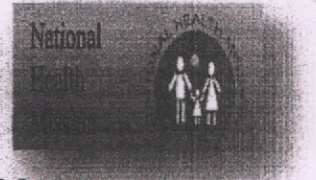

### **Memorandum of Understanding (MoU)**

On Exchange of Students/Faculty  
Between  
Department of Economics  
MGVC Arts, Commerce & Science College, Muddebihal  
And  
Department of Economics  
Government First Grade College, Muddebihal

This Memorandum of Understanding (MoU) is effective as of 01/01-2019 (Effective Date) to establish an affiliation by and between

MGVC Arts, Commerce & Science College, Muddebihal, having expertise in the areas of Economics education and research, affiliated to RCU, Belagavi, India hereinafter referred to as MGVC, MBL of the FIRST PART, And

The Government First Grade College, Muddebihal, affiliated to RCU, Belagavi. Hereinafter referred to as GFGC, MBL of the Second Part, for the purpose of exchange of faculty and students.

The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes.

#### **Preamble:**

WHEREAS, MGVC, MBL and GFGC, MBL have many areas of common interest in Economics Studies, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research.

NOW THEREFORE, MGVC, MBL and GFGC, MBL have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

#### **ARTICLE 1: OBJECT**

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two institutions shall seek to promote:

##### **a. Faculty Exchanges**

- i) The exchange of faculty to the mutual benefit of both institutions,
- (ii) Collaboration in teaching, research s in the field of mutual interest,
- (iii) The exchange of academic materials and publications,
- (iv) Conduct lectures,
- (v) Upgrade of teaching and research skills,
- (vii) Participating in seminars, symposiums, and other types of academic discussions,

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange will be worked out between the institutes.

##### **Student Exchange**

MGVC, MBL agree that student exchange will be guided by RCU, Belagavi. Principles listed below A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined program of study.

- a) Exchange students will be selected by mutual agreement between the home institution and the host institution.
- b) An exchange student will continue to be treated as full-time student at his/her home institution.
- c) An exchange student will be considered as full-time "exchange" student at the host institution.
- d) His/her program of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.

**c. Other Areas:**

- (i) to exchange information and educational programs,
- (ii) to exchange information on teaching, learning material to their educational programs,
- (iv) to organize jointly seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein,
- (v) to propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty to participate therein,
- (vi) to exchange, on a reciprocal basis, students at Graduate levels for limited periods of time for purpose of education,
- (vii) the provision of cultural and intellectual enrichment opportunities for staff and students of both institutes,
- (ix) to permit students, staff and faculty members to use library facility.

MGVC, MBL agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutions.

**ARTICLE 2: COORDINATION**

Each institution shall appoint one member of its teaching/research faculty to coordinate the program on its behalf. MGVC, MBL and a program coordinator from the side of GFGC, MBL, will periodically review and identify ways to strengthen cooperation between the two institutions.

**ARTICLE 3: CONFIDENTIAL INFORMATION**

MGVC, MBL does not absolve any confidential information during the exchange activity.

**ARTICLE 4: VALIDITY**

The Memorandum shall remain in force for a period of five year commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

**ARTICLE 6: TERMINATION**

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution. Once terminated, neither MGVC, MBL will not be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, MGVC, MBL will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

## ARTICLE 7: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

## ARTICLE 8: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the rules and regulations of the institutions.

## ARTICLE 9: LEGAL EFFECT



- g. Either department shall have the right to terminate this MOU upon 60 days prior written notice to the other department.

**5. Confidentiality:**

The Dept. of History VMKSRVC and Dept. of History MGVC agreed to hold in confidence all information/data designated by the departments as being confidential which is obtained from either departments or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other department.



**6. Duration of MOU:**

This MOU unless extended by mutual consent of the departments, shall expire in **Five** years after the effective date specified in the opening paragraph. However on review the MOU shall be extended for another two years by mutual consent.

**7. Coordinators:**

The heads of the departments will have overall responsibility for implementation of this agreement or both departments will designate persons who will have responsibility for coordination and implementation of this agreement.

**7. Coordinators:**


