Right to Information (RTI) Act, 2005

The Honorable President of India gave his consent to Right to Information Act, 2005 on 15/6/2005 and the same has come into existence with effect from 12/10/2005.

The Right to Information Act 2005 sets out the practical regime of Right to Information for citizens to enable them to access the information under the control of public authority in order to promote transparency and accountability in the working of such authority.

As per the act, "**Information**" means any material in any form, including records, documents, memos, e-mails, opinions, Advices, press releases, circulars, orders, log books, contracts, reports, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public Authority under any other law for the time being in force.

As per the provisions of Right to Information Act, 2005 a citizen can seek for information in relation to a public authority which is established, constituted, owned or controlled or substantially financed by funds provided directly or indirectly by the State Government by an application to the Public Information Officer . The Right to Information id a right confirmed on citizens of India only..

Section 2(h) of the act defines "**public authority**" as any authority or body or institution of self governance established or constituted by or under the constitution or by law made by the Parliament or any state legislature or by notification issued by the appropriate government. It includes body owned, controlled or substantially financed by the government.

In accordance with the provisions contained in section 2(j) of the act, **Right to Information** means right to information accessible under this Act which is held by or under control of a public authority.

The college is owned, governed and managed by its management viz. SGVC Vidya Prasarak Trust®, Muddebihal. The college has been included under Section 2(f) and Section 12B of UGC Act, 1956. The college accredited by NAAC (III Cycle 2017). The college discharges its functions in accordance with the rules and regulations established by Rani Channamma University, Belagavi and amended from time-to-time and instructions / orders issued by Directorate of Collegiate Education, Government of Karnataka.

The financial transactions of the Institution are periodical audited by the concerned Government Departments and also internally audited by the Chartered Accountant duly appointed by the management for the said purpose from time-to-time. The college has a
