The grievance procedure is a machinery to sort out the issues between student and college. It is a means by which a student who believe that, he / she has been treated unfairly with respect to his / her academic / administrative affairs or is convinced to be discriminated is redressed. It is a device to settle a problem. It enables to express feelings by initiating and pursuing the grievance procedure in accordance with the rules and regulations of the college. It involves a process of investigation in which 'Student's Grievance Cell' enquires and analyses the nature and pattern of the grievances in a strictly confidential manner. Matters are disclosed to only those, who have a legitimate role in resolving the matter. Emphasis on procedural fairness has been given with a view to "the right to be heard and right to be treated without bias".

**Scope:** The students to approach the cell for their grievances regarding academic matters, examination matters, financial matters, health services, library and other services.

**Objective:** To provide a mechanism to students of the college to air out their grievances and to provide redressal for the same so that they have smooth tenure at the college from the day of admission to their graduation.

#### Grievance Redressal Procedure

The students have to place their grievances in the suggestions box/complaint book placed in college. The coordinator in turn intimates the matter to the committee for necessary action. Final report based on grievance received and resolved will be submitted to the Principal and further course of action will be decided and the same shall be intimated to the students

## Grievance Redressal Committee

The Grievance Redressal Committee shall be constituted at the college with Principal, student welfare officers, student representative. The Grievance Redressal Cell shall receive the complaint and the Committee shall fix a date for hearing the complaint and communicate its decision within ten days of receipt of complaint. The Grievance Redressal Committee shall ensure disposal of every application as speedily as possible, as and not later than a month of receipt of the grievance. On the conclusion of proceedings, the Committee shall pass such order, as may be deemed fit to redress the grievance and provide relief as may be desirable to the affected party at issue. In case of false or frivolous complaint, the Committee may take appropriate action against the complainants.

Anti-ragging cells should be an important part of educational institutions' mechanisms. As per the guidelines of the UGC under the Act of 1956, which is modified as UGC regulations on curbing the menace of ragging in higher educational institutions in 2009, the establishment of an anti-ragging cell is very compulsory.

### **Objectives of the Anti-Ragging Committee**

The Anti-Ragging will be the supervisory and advisory committee for preserving a culture of a rag-free environment on the college campus. The main objectives of this cell are as follows:

1. To inform the students of the dehumanizing effects of ragging inherent in its perversity.
2. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
3. To promptly and strictly deal with the incidents of ragging brought to our attention.
4. To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.

As per the order of the Supreme Court of India and subsequent notification from the University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

1. Any act of indifference, teasing, or handling with rudeness.
2. Any act that prevents or disrupts the regular academic activity.
3. Any activity that is likely to cause annoyance, hardship, psychological harm, or create fear or apprehension.
4. Any Act of Financial Extortion or Forceful Expenditure.
5. Any act of physical abuse causing assault, harm, or danger to health.
6. Any act of abuse by spoken words, emails, SMS, public insults, etc.
7. Any act of injury or infringement of the fundamental right to human dignity.

8. Any act of wrongful confinement, kidnapping, molesting, or committing unnatural offenses, use of criminal force, trespass, or intimidation.
9. Any unlawful assembly or conspiracy to ragging.



### Punishment for those found guilty


Any student or group of students found guilty of ragging on the campus or even outside the campus shall be liable to one or more of the following punishments:

1. Debarring from appearing in any session test or university examination
2. Suspension from attending classes and academic privileges
3. Withdrawing scholarships and other benefits
4. Suspension from the college
5. Cancellation of the admission
6. Withholding the results.

### **The definitions and policies of Anti-sexual harassment cell:**

**Sexual Harassment:** Any unwelcome sexually motivated behavior, whether directed or by implication involving physical contacts or advances, demand for sexual favors, sexually-tainted remarks, and other unwelcome physical, verbal, or non-verbal expressions of sexual nature that affect women's right to work in a congenial environment at the workplace.

**Scope:** The provision of these rules and procedures shall apply to all students, academics, and non-academic staff of our M. G. V. C. College. These rules and regulations shall be applicable to all complaints of sexual harassment made by:

1. A student against a member or members of academic or non-academic staff, co-students, or a member of the academic community against a student or another member of the academic or non-academic community within and outside the campus.
2. A service provider against a student or students or a member or members of the academic or non-academic staff or a student or a member of the academic or non-academic staff against an outsider or service provider if the alleged sexual harassment is reported to have taken place within the campus.

**Functions:** mediation of cases arising out of incidents of sexual assault or sexual harassment occurring on campus; overview of campus security services to ensue prompt intimation to the committee of M. G. V. C. College of all incidents of alleged sexual harassment; organizing of training programs for the staff and the students of M. G. V. C. College to equip them well for handling sexual harassment cases; and assistance to aggrieved parties on campus to make complaints to suitable authorities in deserving cases. Meetings with the students and staff members shall be organized to create awareness and ensure a healthy environment on the campus.

### **Filing of Complaints:**

- Complaints of sexual harassment shall be lodged with the committee. Such complaints should be taken up by the committee for resolution through mediation or conciliation as

promptly as possible, but no later than two days after the complaint on the incident is received.

- The complaints should be made in writing. If the complainant is not able to give it in writing himself or herself, the complaint can be given in writing on his or her behalf by his or her companion.
- Normally, a complaint should be lodged within a week after the incident. In special circumstances, the time limit for the submission of complaints may be extended to a month. The special circumstances that led to the granting of such an extension should be recorded by the committee.
- The complainant is at liberty to withdraw the complaint at any stage of inquiry, provided such withdrawal is made independently and under free will. The inquiry may be terminated upon receipt of the request for such withdrawal.
- A restraint order may be served on the accused, giving him or her a summary of the complaint and warning him or her against making any attempt to exert pressure on the complainant or any other person involved in dealing with the complaint.
- The complainant may bring to the notice of the committee any attempts, if any, made by the accused to violate the order.
- The committee is empowered to terminate the inquiry proceeding and to give an ex-parte decision on the complaint on valid grounds.
- The committee may appoint an inquiry committee to make investigations into the complaint if deemed necessary.
- It shall submit a detailed report communicating its findings based on its investigations. The committee shall pronounce its verdict on whether the accused is or is not guilty. The committee in cases in which the accused is or is found guilty should indicate the gravity of the offense, whether it is major, serious, or minor.

#### **Proceedings of the Enquiry Committee made by the Sexual Harassment Cell**

1. The inquiry committee shall complete the inquiry in the shortest possible time, not exceeding a month from the date on which the complaint is referred to it, except for special reasons.
2. The complainant(s) and the accused shall be given a reasonable opportunity to present and defend their cases. A witness may be called if deemed necessary. In case the accused fail(s) to attend consecutively for three hearings despite call notices for the same, the inquiry may be terminated and the decision taken on the complaint taken on an ex-parte basis.
3. Counseling services may be made available to the victims and the accused on request.
4. If the complainant, the accused, and the witnesses desire to be accompanied by a companion of their choice, they may be permitted to do so, provided the person so chosen will have only observer status and shall leave the meeting after making his or her testimony.
5. The complainant and the accused shall have the right to cross-examine all witnesses.
6. The inquiry committee shall have the right to disallow questions from the victim or the accused if the questions are deemed irrelevant and unnecessary.
7. All persons heard by the inquiry committee, as well as observers, shall take and observe an oath of secrecy about the proceedings.

**Regressive Disciplinary Action:** The inquiry committee would pass on the findings of the investigation to the Honorable Chairperson of the Sexual Harassment Cell for appropriate regressive action. If the chairperson finds that there is a requirement for

further investigation, he may order a review of the report by the inquiry committee and may even refer the case to a competent legal authority if it is of a grave nature.



**False/Baseless complaint:**

If the inquiry committee finds no merit in a complaint, the chairperson of the committee may issue a show-case notice to the complainant, requiring him or her to explain within three days why disciplinary action should not be taken against him or her.
